1.1 Onsite Exhibitor Space Regulations

1.1.1 Key dates

30 September 2021	Application deadline with priority status
From 6 July 2021 until 8 October 2021	Stand rental ($\in 400/m^2$ and $\in 280/m^2$ for the reduced rate)
22 October 2021	Deadline for stand design submission. All exhibitors must submit their insurance certificates. For custom stands, risk assessments and method statements are requested for all structures.
12 November 2021	Stand services deadline - After this date orders will incur an extra cost and the service cannot be guarantee.
19 November 2021	Free Exhibitor badge deadline
22 November 2021	Stand activity declaration deadline
17 November 2021	Additional General Exhibitor badge order deadline
9 - 11 December 2021	EuroEcho 2021

1.1.2 Construction schedule and Exhibition access timetable

1.1.5 Exhibition location and building information

The exhibition accompanying EuroEcho 2021 will be held in the Hall Alpha of the Hub 27 venue in Berlin, Germany.

- Gross area dedicated to exhibits approx. 1000m²
- Ceiling height: hall Alpha: 9.80m
- Exhibition Hall floor weights loading vary depending on the hall:

- Hall Alpha: 10,000 kg/m² floor weight - 3,5t forklift. Please see <u>technical</u> <u>details</u>

- Electricity, water & telecoms delivered by service ducts at floor level
- Dimensions of the loading doors: 5,00m (w) x 4,40m (h). Please see <u>technical</u> <u>details</u>
- First Aid will be next to the Registration Area
- The hall will be fully darkened
- No carpet within the Hall, except on stand spaces

1.1.6 Suspension points

Exhibitors will not benefit from the possibility of having a portion of their stand design suspended.

1.1.7 Stand module - Shell scheme stand - Submission deadlines

By 22 October 2021: Exhibitors renting a shell scheme stand should inform ESC Industry Team accordingly.

A public liability insurance document should be sent by exhibitor to the ESC Industry Team.

A choice of stand solutions is available at attractive package prices for stands up to $25m^2$, which include:

- Structure: walls, 1 sqm digital print on welcome desk (logo print), dark grey carpet, daily basic stand cleaning.

- Lighting: spots on extended arms (1 spot per 4 sqm), 1 electrical basic installation 3,3 kW distribution box with 3 sockets and ground connection, 1floor socket

- Furniture package: counter with stools, waste bin, 1 acrylic spit protection on the welcome desk.

Additional Graphic Optional: full graphic on backwall

The stand module $(6m^2 - 25m^2)$ provided by the official stand service supplier will be uniform stands with uniform graphics, height, and design. Partition walls will be 2,5m high, 0,5m graphics & signage can be added if needed.

1.1.8 Custom stand design - Stands drawing

By 22 October 2021, every exhibitor must submit to the ESC Industry Team, an exact statement of the dimensions of their stand as well as plans and descriptions of this stand.

A public liability insurance document must be submitted as well as all additional certification documentation required for complex structures. All documents for construction certification are required.

1.1.9 Health & Safety certification - Stand module

By 22 October 2021, exhibitors renting a stand module from the official stand supplier should submit the package type, dimensions & non-standard items such as display screens and catering areas. There is no need to provide any specific documentation for a stand construction certification apart from the public liability insurance document.

1.1.10 Stand height allowance

The maximum height allowance is in direct proportion to the m² floor area of each stand and is as follows:

Stands will be assigned in accordance with the accrued point ranking if received by 30 September 2021.

After confirmation of stand assignment, any alteration of the stand type may be requested to ESC before 15 October 2021.

1.2.2 Exhibition page schedule

Delegates have access to the Exhibition page and Exhibitor profiles from 08 December 2021 until 3 January 2022.

Exhibitors' administrator accesses are valid from 1 November 2021 until 30 November 2021.

Traffic on the platform is high following the live Congress, so exhibitors are encouraged to keep their profiles alive and maintain interaction with delegates. Post-Congress, only the Agenda and Ask and appointment feature can be updated.

1.2.3 Exhibitor profile cell

Exhibitors must provide their corporate logos or the product logo of their choice and the subtitle to be shown on their Exhibitor profile cell.

An exhibitor may choose to use a corporate logo or the product logo of his choice. If a product logo is used, the exhibitor's name must appear in the subtitle.

Corporate or product logo format: - 400 x 400 px (png or jpg) - Transparent version + white background version - Max weight 200ko Subtitle file format: 150 characters maximum, spaces included

1.2.4 Exhibitor corporate logo

The exhibitor corporate logo will be displayed in the top left of the profile. Size and position are equivalent for all selected packages.

File format:

- 400 x 400 px (png or jpg)
- Transparent version + white background version
- Max weight 200ko

1.2.5 Exhibitor name and company description

The exhibitor's name and general company description are placed next to the exhibitor's corporate logo. One company website link can be included below the text in a dedicated button. The text must not exceed 500 characters maximum, spaces included.

1.2.6 Exhibitor social media links

Social media links are placed at the bottom of the exhibitor profile. The number of icons is limited to 6 links: Mail, Twitter, Facebook, LinkedIn, YouTube, Instagram.

1.2.7 Promotional video

Exhibitor's promotional video(s) are placed on the top of Exhibitor profiles. This video(s) is aimed at creating brand awareness through a video in which you can introduce overall information about your company or on your products and activities. The recommended length of this video(s) is 3 minutes.

A promotional video is not a session including scientific presentations.

During the on-demand period following the congress, it is not allowed to update these videos.

As an alternative to Exhibitor's promotional video(s), banner(s) promoting Exhibitors's activities at the congress can also be allowed. Hyperlinks to other sections of the Congress are allowed but no hyperlinks to external websites are allowed.

1.2.8 Documents and resources

1.2.10 Complementary link to virtual booth

Exhibitors who have ordered an expert package have the possibility to promote their 2D or 3D virtual booth by adding a clickable visual of their virtual booth. Other display alternatives are possible and will be suggested by our supplier CYIM.

As an alternative to a 2D or 3D stand visual, a link to an external website illustrated by a 2D clickable visual can also be allowed on demand.
