

DESCRIPTION OF SERVICES TO HANDLING TARIFF FOR: **ESC 2015 – London/UK**



POS A1 - B ... Transport and handling costs for airfreight, seafreight + groupage cargo

Cargo delivered by various means (air, sea, road) – this service includes

- handling at receiving point
- transfer to the venue
- delivery to booth

POS C ... Lifting-Handling ex Truck onto stand or ex stand onto truck, direct trailer

Offloading and reloading of lorries arriving directly to the venue
it includes a forklift w.driver to unload or load the truck , delivery from truck to booth or back
and also includes the management of slot times with ref. nrs and marshalling of the trucks

POS D ... Manipulation with Empties & Accessible storage

Empties are empty packing material such as crates ,boxes , cartons or stilleages

It describes the service of collectiing them from booth, transport to warehouse Storage and return delivery to booth. The boxes must be empty for insurance reason

As such packing material will be stacked for storage and are not neccesarly in a locked warehouse structure.

Accessible storage is designed for packages with content and the need for access during the event

They are stored in a guarded warehouse with daily access during the event opening hours.

Fullgoods accessible storage items are goods (brochures, give aways, etc. that don't fit on the booth-capacities ... on request these goods will be picked from booth during build up period and FAIREXX can be ordered by client with partwise delivery.

POS E ... Customs Clearance Formalities

Pos E.1 temporary import	import of goods for a specified period – goods must be reexported after the congress
Pos E.2 final import	final import of goods – no return after congress (taxes & duties apply)
Pos E.3 Import/Export customs clearance per ATA Carnet	Clearance of ATA-Carnet document
Pos E.4 Attendance for customs examination	Provision of a resource in charge of customs examination
Pos E.5 Customs bond fee	Applies for temporary import without ATA. Covers the advance oft he bond guarantee payment. The amount oft he bond guarantee is based on taxes applicable on the total goods value in case of non reexport (CIF)
Pos E.6 pre-financing fee for taxes/duties	fee for taxes & duties paid by Fairexx to customs
Pos E.7 use of FAIREXX tax registration-no.	fee for shipments out of EU-countries for companies that are Customs-wise not registered in EU
Pos E.8 closing of temporary import-file	fee for shipments that where imported at inbound on temporary base, to close the customs file at return of goods after event
Pos E.9 Export customs clearance / T1 transit doc	applies for export customs clearance at re-export to non EU-countries, or a T1 customs document must be prepared on request

POS F ... Labour and forklift hire for working at stand only

Hire of worker or forklift to perform work on booth

POS G ... Other costs / surcharges

Pos G.1	Service charge	Set fee charged to cover the administration costs of a shipment
Pos G.2-5	Surcharges	apply on labour costs & services outside oft he regular working hours
