- Interaction between speakers and audience through an integrated interactive tool available during the live broadcast of the session

- An evaluation form on the page to collect feedback at the end of the session
- Open question interaction to question the audience

Option 1 (Included in your ESC Satellite Symposium package) Self Recording

Pre recorded presentations and panel discussion provided by industry

For this option, the industry is responsible for providing the final video files to be broadcast live, in the dedicated time slot, with the following rules:

- + <u>Submission of recording files by 30th July</u>, provide your file via box. CYIM will give you further instructions via email.
- + Quality
 - + full HD 1080p,
 - + Minimum 30fps and 5Mb.
 - + Codec H264
 - + Maximum size: 5GB
- + 1 file per presentation according to the programme of the session (needed for integration in ESC 365)
- + The duration of each video must match your programme of the session (including time for panel discussion)
- + Splitting presentation is considered post-production and will imply additional costs

Panel Discussion (Live)


- + Technical rehearsals will be scheduled by CYIM for your speakers
- + For the day of your session a dedicated CYIM team will assist you, more information on this slide
- + The Panel Discussion can be either:
 - + Pre-recorded (by the sponsor) and it will be broadcast as it is presented
 - + Or live panel discussion(s), which occurs in real time during your session, ie the panel discussion(s) will be filmed during the session broadcast (more information <u>about Live Panel discussion</u>).

Option 2 (CYIM acts as your agency)

CYIM Recorder Application


Pre-recorded presentations only

- + With this option, each speaker of the session can record their presentation through our CYIM recording platform.
- + The CYIM recorder can be used in full autonomy by the speaker. After downloading the app, the recording can be done at any time and can be redone as many time as needed.
- + The industry will receive the video files for validation prior the congress.
- + Every speaker will be able to contact a dedicated customer service:
 - + To help check the sound and camera quality
 - + To provide assistance on the use of the recorder



Pre-recorded presentations only

- + For the panel discussion, it can be:
 - + Pre-recorded (by the sponsor) and it will be broadcast as it is presented
 - + Or live panel discussion(s), which occurs in real time during your session, ie the panel discussion(s) will be filmed during the session broadcast (more information about Live Panel discussion)
 - + The industry will have the possibly to send a customised background for the recordings and the panel discussion (here are the specifications). The ESC background will be applied by default.
 - + The same customised background will be added to the recorded presentation.




Option 3 (CYIM acts as your agency)

CYIM Virtual Studio Recordings


Pre-recorded presentation and Panel Discussion (live or pre-recorded)

- + With this option, part of or the whole session will be recorded in our studio like a live session.
 - + Speakers will be connected via a visioconference room and will be able to share their presentation.
 - + Industry can either record the whole session, included the panel, in one studio appointment or either book one appointment per speaker according to their availability
- + A dedicated technical team will assist and guide the industry and each speaker during the appointment in order to get the best quality for the recording.
- Speakers will be given several attempts to record their presentation until the official deadline.
- + Post-production: Editing is possible if needed
 - + Remove the blanks and gibbering: The industry needs to provide us the exact timing to be removed
 - + Hide/blurred a slide
 - Shorten a video



Pre-recorded presentation and Panel Discussion (live or pre-recorded)

- + For the panel discussion, it can be:
 - + Pre-recorded (in studio as mentioned in the slide above) and it will be broadcast live
 - Or a live panel discussion, which occurs in real time, the panel discussion will be filmed during the session broadcast (more information <u>about Live Panel</u> <u>discussion</u>)
 - + The industry will have the possibility to send a customised background for the records and the panel discussion (here are the specifications). The ESC background will be applied by default.



Live Panel Discussion for all options





Live panel discussion

- + Panel Discussions can be at the end and in between presentations
- + For the live panel discussion you will need:
 - To validate the session script with industry representative and/or moderators through a meeting with technical team:

During the rehearsal, our technical team will explain the process and will check the equipment matches the requirements.


Please note that a maximum of 6 speakers/moderators can be displayed and talk at the same time during the panel live.







- Computer environment need :
 - + To be plugged to power supply
 - + To be connected to internet with a sufficient bandwidth
 - + To use Chrome browser (prefered because more stable)
- The video on the right shows the 3 key points to follow, to make sure that the quality of sound and camera is good for your presentation
- 3. The agreed conditions and the tools that have been tested during the appointment with the technician, must be the same as those of the day of the live broadcast.



1. You can customise the banner at the top left. Please provide a banner of 100x500px (500 px is the maximum width) in png or jpeg format. Files sources (.psd, .ai...) can also be sent for a better quality.

- 2. You can also provide us a 1920x1080 picture that we will use as a background, please keep in mind that some areas, according to preset used could be hidden by the slide and the speaker camera. Example with this logo:
- If you do not want to use your own company branding, we will keep the general ESC background as a Picture-in-Picture.
- → The final design will be sent to you for validation prior the congress.











Customised background – to be adapted depending on the number of speakers

- + This point will be discussed with CYIM project manager.






Evaluation Form




- + Get feedback from your audience through a customised form
 - + Open throughout the session
 - + Questions with multiple choices or with open text answered
 - + Pre and/or post evaluation form message
 - + The audience have to click on a button in the chat to answer to the evaluation form
 - + The questions appear one by one





- + Get more interaction from your audience by asking **One Question during your**session
 - + The question will need to be asked at the beginning of the session
 - + Audience will have all the time of the presentations to answer the question
 - + Audience will still be able to ask their own questions within the chat



+ Why only **One Question**?

+ For Scientific reason


- + Open your session with a question and discuss it during the panel/Q&A will give more attractiveness for the audience
- + It can be your first question discussed during the panel/Q&A
- + This will motivate audience to ask more questions

+ For Technical reason

- + Due to the latency of the streaming virtual voting is difficult to manage, especially for the person who animates the session and needs to cover the blank
- + The question asked at the beginning of the session enables time to answer the question and avoid the delay issue


+ How will audience vote?

- + Once the voting is active the button to access the voting box appears on the interactivity box on the side of the player 1
- + Audience will click to enter and answer the question 2



+ How are the results shown?


- + The technical team will stop the vote at the end of the presentations
- + Once the speakers/moderators are ready to discuss the answers during the Q&A, the results will be displayed on the screen to the audience 1





+ Which question can I ask?

- + Multiple choice or Pro & Con question is recommended.
- + Question needs to be provided by 13th
 August 2021.
