The purpose of this document is to give you the necessary instructions on how to use the Online Submission System according to the agreed timeline.

1. AGENDA SUBMISSION:

Proposals can only be submitted via the online submission system.

NOTE: ESC is unable to process proposals received via email, mail or fax.

LOG IN: To submit your agenda online you will need to log in with your ESC Account - if you do not have one yet you can create it at your first connection. (free and simple steps to create)

2. SUBMISSION TIMELINE

15 July	By this date, your agenda must be entered in the Online Submission System at least as a draft – if you are still missing some faculty names - (meaning you can still edit and modify the agenda).
16 July – 22 July	CLOSED: Online Submission System will be closed during the review period.
23 July – 7 August	OPEN: Online Submission System will be OPEN for minor edits

3. SESSION TYPE & FORMAT

Industry Live - Broadcast your ground-breaking science to a global audience on our dedicated Live Programme (30 minutes or 45 minutes).

Industry Q&A session – Broadcast your pre-recorded session on our various Topic Channels during our dedicated time slots with live Q&A interaction between panelists and audience (60 minutes).



4. SUBMISSION QUICK OVERVIEW:

1. Once connected to 'My Sessions':
 - a. You can view your **Dashboard** (list of the sessions you have entered in the system).
 - b. Click on 'Create a new session' to start a NEW submission
 - c. Click on the session appearing in your dashboard to finalise / modify an existing entry
 - d. 'Submission rules & guidelines' are also available for consultation on this page.
2. Once you start working on your submission. Please be informed:
 - a. **IF YOU CLICK SAVE** = your session is saved and will appear as a draft on your dashboard and in our system and you can reaccess it at any time until the deadline. Please note that it will not be considered for the programme until you have clicked submit
 - b. **IF YOU CLICK SUBMIT** = it means your programme is ready to be shared with ESC , for review by CPC Chairs and for publication. Sessions not in Submitted/Selected Status will NOT appear in any programme.
3. Once submitted, if you need to amend a session within the open timeline period, please contact industryprogramme@escardio.org who will be able to revert the status to draft, for you to be able to make your edits.
4. In case of a duplicate submission, only the most recent version will be kept and any previous versions will be deleted.

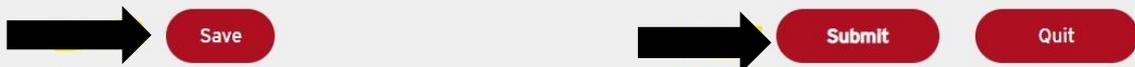
