COACH PARKING AT CONGRESS VENUE (AMSTERDAM RAI)

The ESC Congress has a strict traffic plan in order to allow congestion-free access to all delegates. **Buses and** coaches will not be allowed to freely drop off, pick up, park or wait outside the Congress Venue. All vehicles taking guests to or from the Congress must pre-book their parking space using this form. Each vehicle will be allocated a specific space (see map).

ENTRANCE POLICY (first check if your coach is registered or unregistered):

The registered coaches will be escorted by our attendants to their official parking location at Amsterdam RAI (P8, P9 or P10). The drop-off location is also the boarding location. The coach driver will receive a voucher with a unique number and the location of where exactly the coach is parked. The voucher must be placed behind the windscreen. All passengers will receive a similar voucher, to find their coach more easily upon leaving.

The rate per registered coach per day is EUR 50,- net and include VAT. Payment at Loge P7 (main entrance) by cash or credit card. You will receive a receipt, which must also be placed behind the windscreen.

The unregistered coaches will be escorted by our attendants to their official parking location at Amsterdam RAI (P8, P9 or P10, if available). The drop-off location is also the boarding location. The coach driver will receive a voucher with a unique number and the location of where exactly the coach is parked. This voucher must be placed behind the windscreen. All passengers will receive a similar voucher, to find their coach more easily upon leaving.

If P8, P9, P10 locations are full, our attendants will escort the unregistered coaches to drop-off location P6. After drop off at area P6, the coach will be driven empty to parking area P17/P18. There will be an attendant at P6 to call P17/P18 when the group is ready for pick up. Travel time between P17/P18 and P6 is approximately 5 minutes.

The rate per unregistered coach per day is EUR 75,- net and include VAT. Payment at Loge P7 (main entrance) by cash or credit card. You will receive a receipt, which must be placed behind the windscreen.

Only stop and go coaches can drop off and pick up passengers at location P6 (with a maximum of 10 minutes).
