The Delegate Bag Insert is a tool through which an invite, created by Industry, in the form of a printed document, is placed in the official ESC Congress 2013 Congress Bags (23 500).

The number of Delegate Bag Inserts in the Congress Bags is limited to 35 Quantity to be printed 23 500 Maximum size A4 (21 X 29.7 cm)

Maximum weight 40g

No product logos or names will be allowed on the Delegate Bag Insert

In order to facilitate approval of your artwork, we recommend using the same artwork for the Pre-Congress Mailing Insert, Delegate Bag Insert, Weblink & Industry Sponsored Session info screen.

> <u>Procedure</u>

The exhibiting company must send us a duly-completed e-application form. The ESC will then issue an invoice. The insert must be approved by the ESC before printing and shipping. The ESC will provide the delivery address to the company after the artwork is approved. The company is responsible for printing and shipping its Delegate Bag Inserts to the correct address
