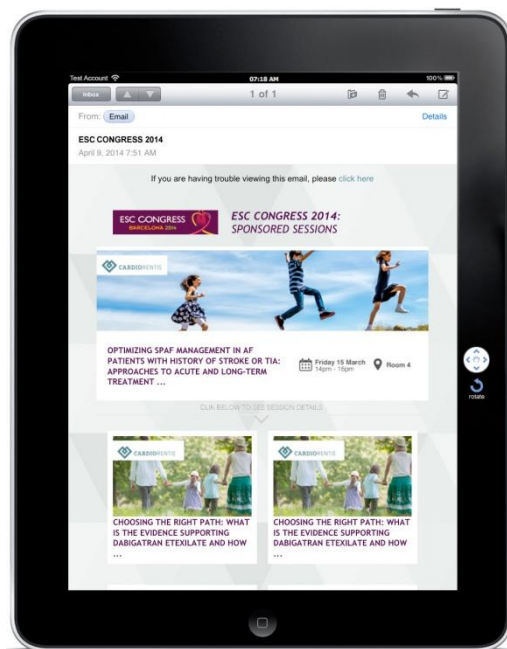
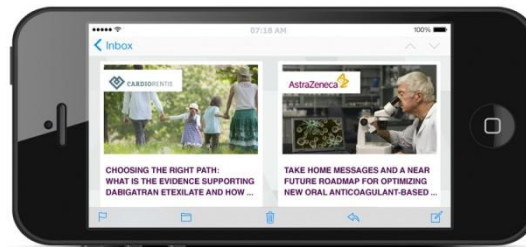

➤ Procedure

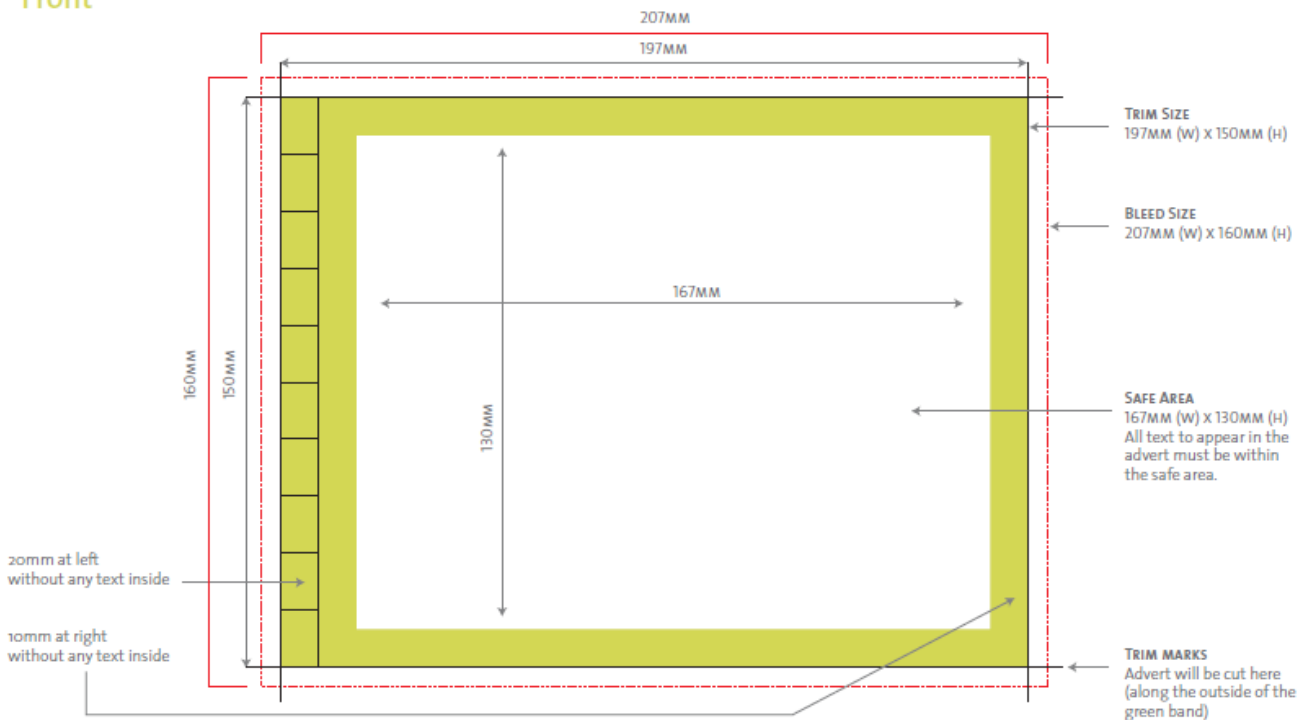

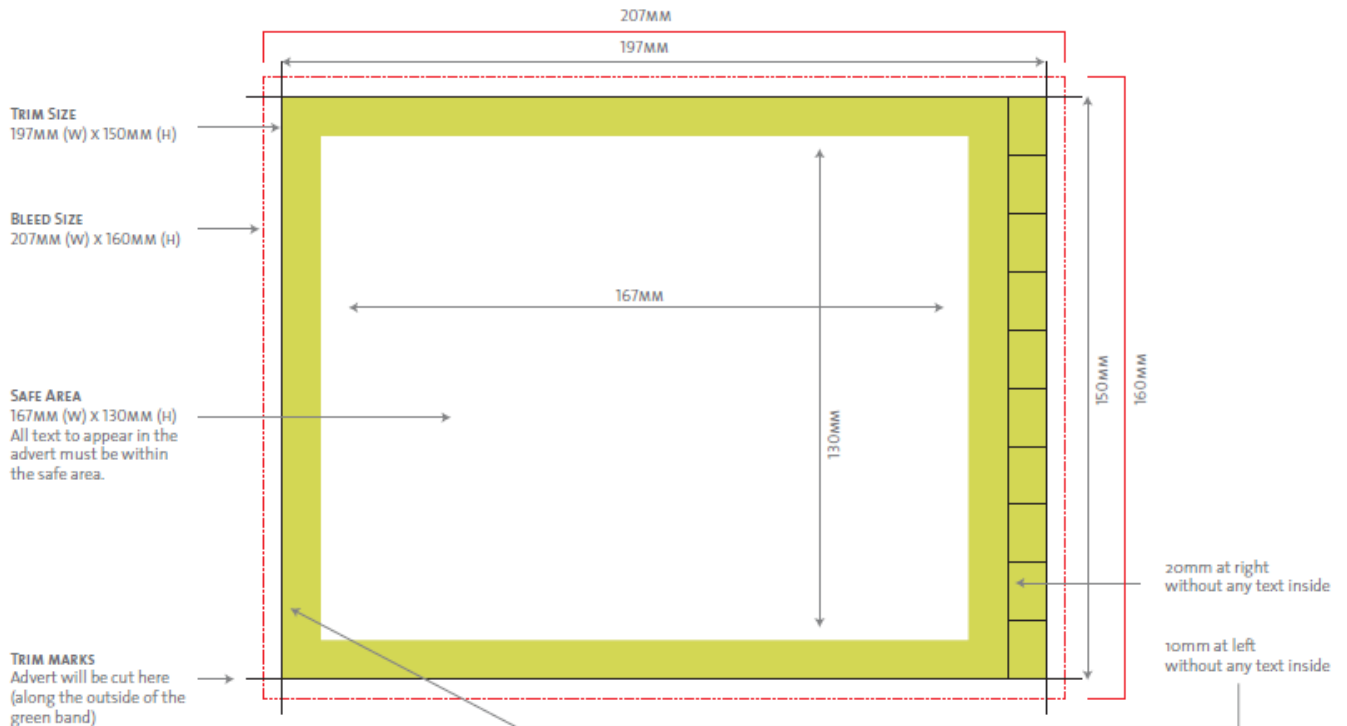

INFORMATION SCREEN

Information Screens are used in several strategic locations throughout the congress centre to display messages on the congress programme and events. These screens will be the perfect medium to carry your advertisement. The congress centre will offer **53 screens to display your messages**.

➤ Procedure

The sponsor must send the files for ESC approval. The sponsor has 30 seconds allocated for each loop of his advert. The sponsor must provide ESC with a 30 second PowerPoint presentation, number of slides still need to fit in the 30 second frame time. Videos in PowerPoint presentations are allowed. The advert must be approved by the ESC.
