- 4. The exhibitor is obliged to provide for the accessibility of the floor connector holes by cutting out the podium and all other covers and structures or by leaving connection points free. The exhibitor shall bear liability for any cost or damage occurring as a consequence of failure to fulfil this obligation and/or for impeding any public utility connection or fault repair activities.





- 5. HUNGEXPO Zrt. will provide telecommunication and Internet connection and usage as an intermediated service, through the contractor it shall have commissioned.
- 6. Devices/equipment are taken over and returned in exchange for a receipt. If a rented device is not returned in full and in an operational condition after the closure of the exhibition to the lessor, Hungexpo Zrt. will be entitled to invoice the price of the device at market price together with the invoice made out for the use of the service.
- 7. In the case of the ordering of fixed line telephone stations, Internet connections and equipment the place of installation should be marked in a schematic drawing and attached to the order. If a customer intends to put up an exhibition at more than one stand the telecommunication services should be ordered by stand, on separate order forms, with the floor plans attached.
