## 2.Case marking



ase Marking

#### All your packages should be clearly marked as follows:

- EuroPrevent 2009
- Name of Exhibitor
- ➤ Hall
- > Stand number
- Package nr. 1 of ... / 2 of .... / 3 of ... etc.

We kindly ask you to use save and strong packing material which is strong enough to be re-used after the show.

## 3. Documentation required for customs clearance



For shipments from outside of the European Union, we need the following documents for the customs clearance:

- ATA carnet
- Proforma invoice / packing List in English, showing: No. of units / weights / dimensions / total no. of boxes / values / full description of items in English
- separate invoices for temporary importation and permanent importation

All exhibits / materials entered under temporary importation are subject to control and examination by Swedish customs for inward and outward movements.

Any material remaining in Sweden or the EU after closure of the exhibition are subject to duties and/or taxes. Payments must be guaranteed prior to removal of goods from the exhibition venue.





## 4. Courier shipments



We strongly recommend exhibitors not to send courier shipments direct to the showsite.

Courier

If you do send goods by courier we suggest that you send them to our warehouse address mentioned under roadfreight.

Reception & storage of courier shipment up to 5 kg. sent to that address (only EU goods in free circulation – NO bonded goods) and which will be picked up at the Fairexx office by the client, are free of charge.

For shipments not consigned to Fairexx but directly to the exhibitor and stand, no liability is accepted.

## 5.Insurance

Insurance

We strongly recommend that all exhibitors arrange insurance coverage of their shipments. Insurance must include transport to and from the exhibition, whilst on display and in storage.

When needed, please contact us for further information and rates.

## 6. Storage of empty packing materials



Storage

All empty packaging materials which must be stored during the exhibition must be labelled with our "empty labels".

Unless otherwise agreed all packages carrying this label are considered as empty.

No responsibility can be carried for goods left in the packages.

For insurance, fire regulations and security reasons, empty packaging materials may not be stored behind booth display nor in the loading bays.



## 7. Methods of payment



Please note following methods of payment are accepted:

- Bank transfer please provide a copy of the transfer statement
- Credit card (MASTERCARD / VISA)
  (please inform us of your card details in advance)
- Cash: all major currencies accepted
- When shipment is sent via one of our agents, you will be billed by our agent

### 8. Basic conditions of contract



- All work undertaken is subject to the German Forwarders terms and conditions ADSp, newest edition and the SLVS - liability policy, in conjunction with the conditions and rates for trade fair transportation.
- > All special transport and crane services are based upon the "Basic conditions of contract for special transport and crane services BSK" latest edition.
- The liability of FAIREXX Logistics for Exhibitions GmbH as Fairs & Exhibitions Forwarder, ceases with deposit and restarts with collection of the freight at the exhibition stand, unconsidered of the exhibitors absence at the stand, irrespective of the submission of waybills at the exhibition forwarding agent's office. Place of jurisdiction AG Gelsenkirchen- Buer for both sides.
- Our invoices will be due immediately after issuance without any further notice according to ADSp. Customers not known to us or with whom we have not agreed any terms of payment, will be asked to pay our expenses before the event starts or on-site during the event or before return shipping of their exhibits.
