- **1. ADDITIONAL SERVICES. BILLING. PAYMENT:** Any service not provided in the initial request and required before and / or during the performance of the service will be billed at the end of the service, and payment must be made by bank transfer on the coordinates indicated in the invoice. Both for the sum due for the services that for the amounts due for any additional services, in the event of nonpayment within the time allowed, will be applied the interests of Legislative Decree 231/02.
- **2. PROHIBITION OF WITHDRAWAL**: Customer can not withdraw from the contract for any reason and, therefore, even in the event of cancellation of the initiative in relation to which the service had to be provided, the amount provided will still have to be paid.
- **3. CONFIRMATION:** So that the contract can be considered effective in all its parts, this document must be returned to LadyDi via email info@ladydi.it or fax (+39 02 89767161) properly initialed on each page and signed at the bottom.
- **4. RESPONSIBILITY:** The organization and planning of the initiative for which will be provided the service is borne solely by the customer, who agrees to hold harmless LadyDi and its employees from any damages, costs, charges or expenses caused to the location, to its staff or third parties arising from willful conduct or negligence of the participants. In any case the responsibilities of the Customer are recognized for any damage caused by the company itself in connection with the execution of this contract. Lady Di srl will be exonerated from any civil, administrative and criminal responsibility connected with the promotion.
- **5. INDEMNITY:** For the whole duration of the contract, the customer agrees to comply with all regulations regarding public and private events, and in particular as regards the necessary permissions for the event itself, with complete relief of liability by the company.
- **6. EXPRESS TERMINATION CLAUSE:** Without prejudice to laws in force in the termination of contracts, LadyDi may terminate in accordance with article 1456 cc by notice in writing by fax and/or e-mail this Agreement, in the event of non-payment of the sums due from the customer if such delay exceeds three (3) calendar days.
- 7. APPLICABLE LAW AND JURISDICTION: All disputes relating to the validity, effectiveness, performance, termination and/or interpretation of this contract and/or of the attachments are of exclusive competence of the Bar of Milan, applying Italian law.
