SHIPMENTS FROM OUTSIDE THE EU (= customs clearance required!)

AUSTRIAN CUSTOMS PROCEDURES COULD REQUIRE A DEADLINE FOR ARRIVAL OF 14 DAYS (!!) PRIOR TO DELIVERY DATE !! THEREFORE WE STRONGLY RECOMMEND TO MAKE USE OF OUR TRANSIT OPTION VIA OUR MUNICH FACILITY WITH EU-CLEARANCE IN GERMANY AND TRANSIT TO VIENNA

Documentation required for Customs Clearance

For shipments outside of the EU, we require the following Documents for the customs clearance:

- > 3 Originals of Proforma Invoice / packing List in English, showing weights / sizes and values / exact description
- > separate Invoices for Temporary Importation (Exhibits) and and permanent Importation (consumables, brochures etc)
- if necessary: Certificat of Origin (Form A / EUR.1)
- if necessary: Special certificates (health / veterinary)

All exhibits / material entered under temporary importation are subject to control and examination by EU customs for Inward and Outward movements. Any exhibits remaining in Greece or the EU after closure of the Exhibition are subject to Duties and / or Taxes. Payments must be guaranteed prior to removal of goods from the Exhibition venue.

- ➤ All special transport and crane services are based upon the "Basic conditions of contract for special transport and crane services - BSK" latest edition.
- The liability of FAIREXX Logistics for Exhibitions GmbH as Fairs & Exhibitions Forwarder, ceases with deposit and begins with collection of the freight at the exhibition stand, even during the exhibitors absence, irrespective of the submission of waybills at the exhibition forwarding agent's office.
