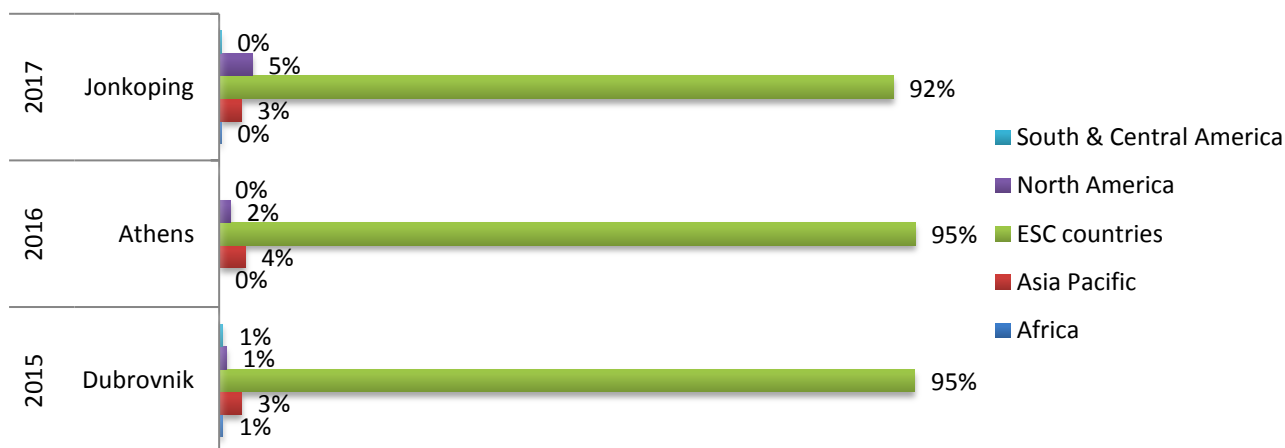

Attendance breakdown by Region 2015-2017

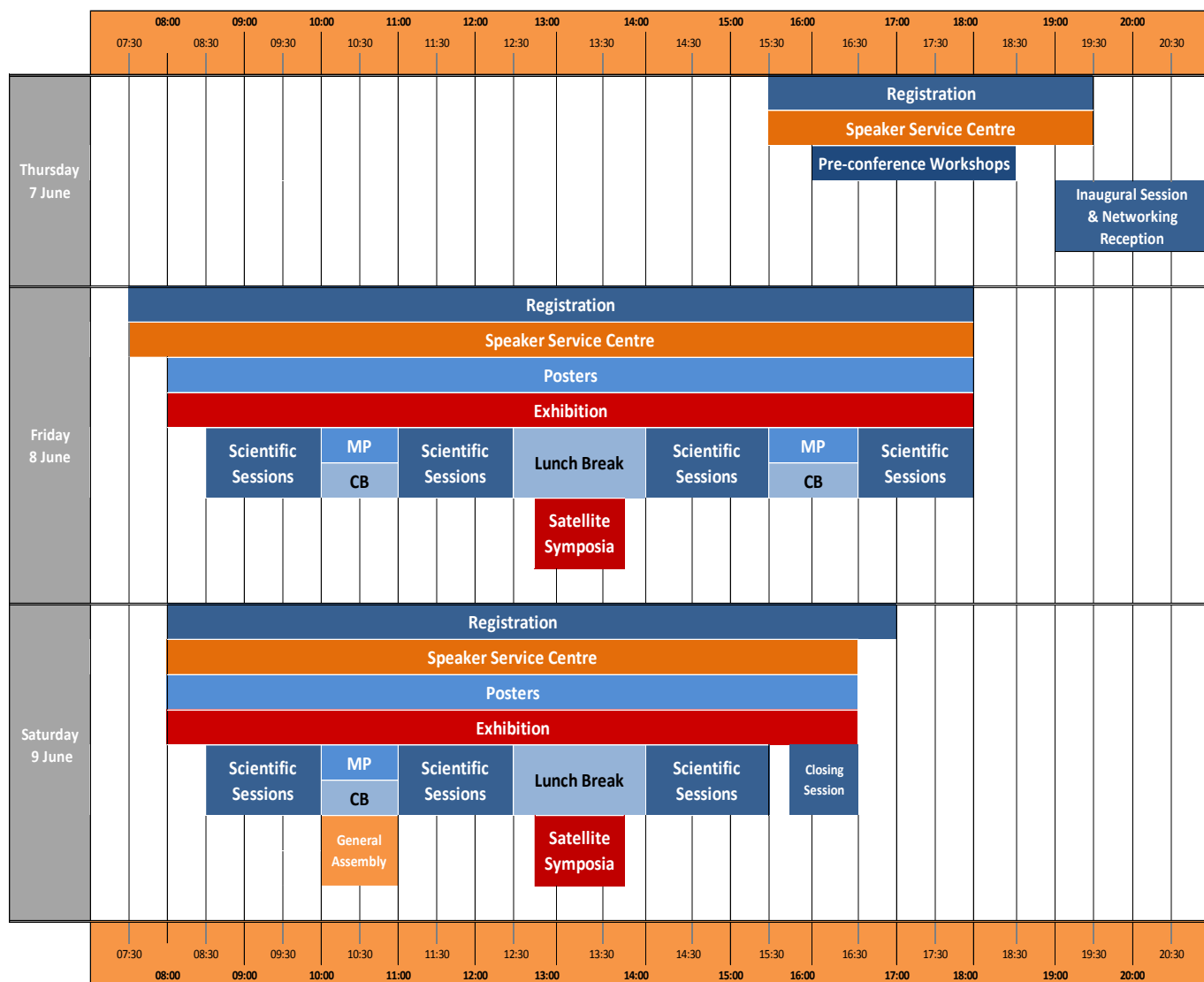
