Customers not known to us or with whom we have not agreed any terms of payment, will be asked to pay our expenses before the event starts or on-site during the event or before return shipping of their exhibits.



1. Consigning of shipments & Deadline dates

AIRCARGO

Airfreight shipments should arrive by latest June 17th 2005 !!

ROADCARGO

Roadfreight shipments (no full trailer loads) should arrive at following address no later than June 16^{th} 2005 !!

2. Documentation required for Customs Clearance

CARNET A.T.A. :

For temporary importation ATA Carnet is strongly recommended.

ATA Carnet with a packing list or Proforma invoice and EUR 1 (2) certificate (where applicable) or other certificate of origin are required.

Combined commercial invoice and packing list :

For shipments outside of the EC , please issue combined proforma invoice and packing list on your company letterhead in English, separated each for temporary and permanent importation.

We require 2 copies of a combined commercial invoice and packing list with original signatures and company stamp.

The invoice must contain the following :

- * full description of all items with individual quantities in English
- * the name of the exhibition, location, Hall & stand no.
- * gross/net weights in kilos, sizes (measurements in centimetres) of each case
- * unit & total values of each case
- * the exhibitor's name and address with contacts & VAT number

Please provide combined commercial invoice together with a copy of CMR or airway bill (AWB) for airfreight shipments at least 1 day before Arrival in advance to us by Fax '49/30-44 03 47 79.

All invoices must show country of origin and specify Temporary or Permanent importation.

Please issue separate invoices for temporary/or permanent importation. A specimen Invoice is included in these instructions.

Sandra Günther All exhibits / material entered under temporary importation are subject to control and examination by Czech customs for Inward and Outward movements. Any Exhibit remaining in Czech Republic or the EU after closure of the Exhibition are subject to Duties and / or 19 % Taxes. Payments must be guaranteed prior to removal of goods from the Exhibition venue.

3. Insurance

We strongly recommend that all exhibitors arrange Insurance cover to include Transit to and from the exhibition, whilst on display and in storage. Please contact us for further information and rates.

4. Case Markings

All packages should be clearly marked : "Name of Exhibitor " "EUROPACE 2005 Prague" c/o FAIREXX / BECKSPEDITION Prague Exhibitor's name / Hall & Stand no. Case no. :

1 of _, 2 of _, (ex: one shipment of 2 pieces = 1/2, 2/2)

5. Courier shipments

We strongly recommend Exhibitors not to send Courier shipments direct to your stand unless you have a member of your staff present to receive them . If you do send goods by courier we suggest that you send them to our adress mentioned under Roadcargo in Section 1.

For shipments sent directly to the stand no liability is accepted.



6. Late arrival surcharge

Any shipments arriving after our deadlines that require Customs clearance will be subject to a late arrival surcharge of 25 % on our tariff .

7. Payment
