Transfer - even in part - of the rights and obligations arising from the order to third parties is not permitted.

Value Added Taxation

In this case the customer must auto reverse the VAT in their home country. Companies registered in a country outside of the European Union are encouraged to seek advice on reclaiming VAT payments.
