Additions:

The compressed air supply is available during the stand set-up period for two days before the start of the fair and for one day after the fair has ended (from 8.00 to 19.00). If the compressed air supply is needed earlier, any additional charges will be based on the compressed air requirement in l/min. Installation of the main compressed air connection is carried out using **one** installation channel.

Usage of neighbouring channels for internal stand installation or secondary installations is not included in connection price and will be invoiced separately depending on time involved. During the fair the compressed air will be available for about 1 hour before and after the opening times.

Connection and supply conditions for compressed air

1. Exhibitors using their own compressor must notify the Technical Exhibition Services Division. Please note that the halls are not equipped with permanent connections for compressed air.

Orders for compressed air connections must be made with forms 5.4 and 5.5. The order and ground plan/plans must be submitted to the **Technical Exhibition Services Division** of Messe München GmbH no later than the date specified in the Exhibitors' Service Booklet. No guarantee can be given that connections applied for after this date will be installed on time.

A surcharge (item no. 36951) amounting to EUR 42.50 will be raised for any late orders submitted once the general stand assembly period has commenced. Moreover, MMG reserves the right to charge a supplement on the above prices for orders submitted after the closing date.

In the event of repair work on equipment not installed by Messe München GmbH a surcharge will be added to the standard hourly rate.

2. MMG reserves the right to install the compressor for the compressed air supply at the exhibition stand (e.g. if only a limited supply of compressed air is required). The compressors are operated at a pressure of 10 bar. If a lower pressure is required, a pressure-reducing valve must be installed and included in the order. Compressed air connections up to 60 bar or nitrogen systems can also be ordered but in either case a separate quotation must be obtained.

The complete compressed air system (incl. materials) is only rented to the exhibitor. The exhibitor's attention is again drawn to the liability regulations contained in Section 5 of the General Terms of Contract for the Exhibitors' Service Booklet.

3. The list of dimensions and tolerances supplied to the exhibitor or ordering party must be checked, countersigned and returned as soon as possible. This list is also used subsequently for invoicing purposes. Any complaints concerning the products or services provided must be addressed to Messe München GmbH, Technical Exhibition Services Division before the stand is dismantled so that a proper inspection can be carried out. Subsequent complaints about the products or services provided will not be admitted.

4. If an order is cancelled less than 14 days prior to the start of the trade fair or exhibition the ordering party shall be required to pay a lump sum amounting to 75% of the costs of the ordered services. The exhibitor shall still have the right to provide proof that such an amount is in excess of the saving in outlay accruing to MMG.

5. Prices include the following services depending on the item number:

Total compressed air requirement, basic installation

Provision, installation and dismantling of the equipment (compressors, compressed air tanks, refrigerating dryer), laying the compressed air pipes to the connection point at the stand (excluding further distribution within the stand), servicing of this installed equipment and the power supply for the equipment supplied by MMG. Installation of the main compressed air connection is carried out using **one** installation channel. Usage of neighbouring channels for internal stand installation or secondary installations is not included in connection price and will be invoiced separately depending on time involved.

Appliance take-off points at the stand

Connection to the basic connection, fittings, hardware, servicing of this installed equipment and installation, dismantling. **Excluding compressed air pipes** (piping will be charged separately according to length). The size of the appliance take-off point will be based on the total connection capacity in l/min.

Machine connection at the stand

Connection to the basic connection or load take-off point, fittings, hardware, servicing of this installed equipment and installation, dismantling. **Excluding compressed air pipes** (piping will be charged separately according to length).

The size of the machine connection will be based on the total connection capacity in l/min of the machine to be connected.

Pressure-reducing valve

Installation and rental of a pressure-reducing valve incl. manometer for take-off pressure of 0.5 - 10 bar.
